ICOM-CC does not hold an annual meeting every year, only at the end of the triennial period (2011). However, it holds a meeting during the ICOM General Conference. This year ICOM-CC had a session at the ICOM General Conference in Shanghai on November 8, 2010. The session was based on the broad theme of "Conservation in a Changing World". It served as a positive platform for showcasing ICOM-CC to the broader ICOM membership. The session included both a formal paper presentation session as well as field visits. The half-day paper presentation session was simultaneously translated in English and Mandarin and was attended by over 120 registered delegates. This was followed by a visit and informal discussions at the Conservation Laboratory of Shanghai Museum on November 9 and a visit and informal discussions at the Conservation Laboratory of the Zhejiang Province Museum and China Silk Museum on November 10, 2010. As no expenses were incurred in relation to this meeting, section B) 2 is not completed.

Annex II: ICOM-CC Strategic Plan for 2008-2011

During the triennial period (2008-2011), ICOM-Committee for Conservation (ICOM-CC) will be guided by the following four strategies developed during its board meeting in Lisbon, March 12-15, 2009.

Strategy 1

Continue to be an organisation that provides its members increased opportunities to communicate both amongst its own members and with external heritage professionals

Specific Actions

- Organize the ICOM-CC session at the ICOM General Conference, Shanghai, China, November 7-13, 2010 on the Theme: Museums and Harmonious Society
- Organize the 16th Triennial Conference in 2011
- Produce a high quality peer-reviewed preprints for the 16th Triennial Conference in 2011
- Select venue for the 17th Triennial Conference in 2014
- Provide a dynamic website with constantly updated contents

Strategy 2

Develop closer links with other conservation organisations to better pool resources as well as to improve services for its members

Specific Actions

- Investigate collaborative opportunities with IIC including options for a joint conference in 2014
- Develop closer links with national/international associations especially as an effective mechanism for two-way exchange of conservation information

Strategy 3

Promote ICOM-CC and the conservation profession

Specific Actions

- Promote and post the recently accepted conservation terminology on the website
- Work closely with Working Groups in developing an ICOM-CC brand for all its activities and promotional materials
- Develop and disseminate promotional materials both about ICOM-CC and conservation
- Develop an approach where all ICOM-CC Working Groups are involved in exploring greater public involvement

- Create a new information mechanism "e-news" to communicate to the membership about ICOM-CC activities in a broader organisational level
- Expand its membership base outside Western Europe and North America in order to be more inclusive outside Western countries.
- Following the definition of the conservator-restorer developed in 1984, develop a new document on 'The definition of the conservation profession"
- Generate a discussion on education of the conservation professional

- Update by-laws (minor updates to comply with comments received from ICOM) and Manual for Coordinators

- Communicate the process of joining ICOM-CC through ICOM for the wider ICOM membership
- Evaluate preprint process and make changes, as necessary
